 - Stewart Brown "didn't know better than to allow[] the approval of ... an inherently conflicted loan."
 - The directors did not recognize their duty was to the shareholders and not to Jon Wheeler
 - The "directors appear to have been dead asleep."

We remind you that the filing persons are responsible for the accuracy and adequacy of their disclosures, notwithstanding any review, comments, action or absence of action by the staff.
