## Item 8.01 Other Events

### *Results of June 2024 Series D Preferred Stock Redemptions*

- The ninth monthly “Holder Redemption Date” occurred on June 5, 2024.
- The Company received no redemption requests from any holders of its Series D Cumulative Convertible Preferred Stock (the “Series D Preferred Stock”)

### *Cumulative Series D Preferred Stock Redemption Information (Unchanged from May 2024)*

- To date, the Company has processed 182 redemption requests, collectively redeeming 948,631 shares of Series D Preferred Stock.
- Accordingly, the Company has issued approximately 2.8 million shares of its common stock, par value \$0.01 (“Common Stock”) (as adjusted for the Company’s May 16, 2024 one-for-24 reverse stock split (the “Reverse Stock Split”)) in settlement of an aggregate redemption price of approximately \$35.9 million.
- As of June 6, 2024, the Company had 2,834,237 shares of Common Stock (as adjusted for the Reverse Stock Split) and 2,577,240 shares of Series D Preferred Stock outstanding.

### *July 2024 Redemptions*

- The deadline for the next monthly round of Series D Preferred Stock redemptions is June 25, 2024.
- The next monthly Holder Redemption Date will occur on July 5, 2024.
