#### **Item 8.01 Other Events**

#### Adjustment to Conversion Price of 7.00% Subordinated Convertible Notes due 2031

Item 8.01 of this Current Report on Form 8-K as to the redemptions by the holders of Wheeler Real Estate Investment Trust, Inc.'s (the "Company") Series D Cumulative Convertible Preferred Stock (the "Series D Preferred Stock") is incorporated herein by reference.

Prior to April 7, 2025, the conversion price for the Company's 7.00% Subordinated Convertible Notes due 2031 (the "Notes") was approximately \$4.56 per share of the Company's common stock, par value \$0.01 ("Common Stock") (approximately 5.48 shares of Common Stock for each \$25.00 of principal amount of the Notes being converted).

For the April redemptions, the lowest price at which any Series D Preferred Stock was converted by a holder thereof into Common Stock was approximately \$3.58. Accordingly, pursuant to Section 14.02 (Optional Conversion) of the indenture governing the Notes, the conversion price for the Notes was further adjusted to approximately \$1.97 per share of Common Stock (approximately 12.69 shares of Common Stock for each \$25.00 of principal amount of the Notes being converted), representing a 45% discount to \$3.58.

### **Results of April 2025 Series D Preferred Stock Redemptions**

- The 19th monthly "Holder Redemption Date" occurred on April 7, 2025.
- The Company processed 13 redemption requests from holders of its Series D Preferred Stock, collectively redeeming 38,990 shares of Series D Preferred Stock for a
  redemption price of approximately \$40.75 per share (\$25.00 per share plus the amount of all accrued but unpaid dividends to and including the April 7, 2025 Holder
  Redemption Date) (the "Redemption Price").
- The Company settled the aggregate Redemption Price through the issuance of 443,715 shares of it Common Stock.
- The volume weighted average of the closing sales price, as reported on the Nasdaq Capital Market, per share of Common Stock for the ten consecutive trading days immediately preceding, but not including, the April 7, 2025 Holder Redemption Date was approximately \$3.58.

#### **Cumulative Series D Preferred Stock Redemption Information**

- To date, the Company has processed 334 redemption requests, collectively redeeming 1,616,833 shares of Series D Preferred Stock.
- The Company has issued approximately 811,800 shares of its Common Stock in settlement of all such redemption requests in the aggregate.
- As of April 8, 2025, the Company had 1,033,215 shares of Common Stock and 1,936,274 shares of Series D Preferred Stock outstanding.

## May 2025 Redemptions

- The deadline for the next monthly round of Series D Preferred Stock redemptions is April 25, 2025.
- The next monthly Holder Redemption Date will occur on May 5, 2025.
